SECTION 4 - EMERGENCY AND FIRST AID PROCEDURES	
<b>Scheduled Poisons</b>	Poisons Information Centre in Christchurch, New Zealand can provide additional assistance for scheduled poisons. (Phone New Zealand 0800 764 766).
<b>First Aid Facilities</b>	Normal washroom facilities.
<b>Skin contact</b>	Wash skin with plenty of water. Remove contaminated clothing and wash before re-use. Seek medical advice (e.g. doctor) if irritation, burning or redness develops.
<b>Eye contact</b>	Immediately irrigate with water for at least 20 minutes. Eyelids to be held open. Seek medical advice (e.g. ophthalmologist) if any irritation persists.
<b>Ingestion</b>	Do NOT induce vomiting. Rinse mouth thoroughly with water immediately. Give water to drink. If vomiting occurs, give further water to achieve effective dilution. Seek medical advice (e.g. doctor).
<b>Inhalation</b>	Remove victim to fresh air away from exposure - avoid becoming a casualty. Seek medical advice (e.g. doctor) if symptoms persist.
<b>Advice to Doctor</b>	Treat symptomatically. All treatments should be based on observed signs and symptoms of distress of the patient.

SECTION 5 – FIRE FIGHTING MEASURES	
<b>Fire and Explosion Hazards</b>	Not combustible. However if involved in a fire will emit toxic fumes.
<b>Extinguishing Media</b>	Use an extinguishing media suitable for surrounding fires.
<b>Fire Fighting</b>	Keep containers exposed to extreme heat cool with water spray. Fire fighters to wear self-contained breathing apparatus if risk of exposure to products of combustion or decomposition. Evacuate area - move upwind of fire.

SECTION 6 – ACCIDENTAL RELEASE MEASURES	
<b>Emergency Procedures</b>	No HAZCHEM code.
<b>Occupational Release</b>	Minor spills do not normally need any special clean-up measures. In the event of a major spill, prevent spillage from entering drains or water courses. For large spills, or tank rupture, consider initial evacuation distance of 200 metres in all directions. Stop leak if safe to do so. If available, use water spray to disperse vapour. Wear appropriate protective equipment as in section 8 below to prevent skin and eye contamination. Spilt material may result in a slip hazard and should be absorbed into dry, inert material (e.g. sand, earth or vermiculite), which then can be put into appropriately labelled drums for disposal by an approved agent according to local conditions. Residual deposits will remain slippery. Wash area down with excess water. If contamination of sewers or waterways has occurred advise the local emergency services. In the event of a large spillage notify the local environment protection authority or emergency services.

SECTION 7 – HANDLING AND STORAGE	
<b>Handling</b>	Avoid contact with incompatible materials. When handling, DO NOT eat, drink or smoke. Keep containers closed at all times. Avoid physical damage to containers. Always wash hands with water after handling.
<b>Storage</b>	Store in a cool, dry, place with good ventilation. Avoid storing in aluminium and light alloy containers. Store away from incompatible materials (Section 10). Keep containers closed at all times – check regularly for leaks.

<b>POTENTIAL HEALTH EFFECTS</b>	
No adverse health effects expected if the product is handled in accordance with this Safety Data Sheet and the product label. Symptoms or effects that may arise if the product is mishandled and overexposure occurs are:	
<b>Ingestion</b>	
<b>short term exposure</b>	Swallowing may result in a burning sensation in the mouth, throat, oesophagus and digestive system.
<b>long term exposure</b>	No information available.
<b>Skin contact</b>	
<b>short term exposure</b>	This product is mildly irritating to skin. Persons with pre-existing skin conditions may be sensitive to this product. In contact with water, an alkaline solution will be formed (pH 11 – 11.5).
<b>long term exposure</b>	Prolonged and repeated skin contact with undiluted solutions may induce eczematoid dermatitis.
<b>Eye contact</b>	
<b>short term exposure</b>	This product is irritating to eyes.
<b>long term exposure</b>	No information available.
<b>Inhalation</b>	
<b>short term exposure</b>	Not a dust hazard in moist form as supplied. Not a dust hazard when set. Sanding or grinding of set dry putty will generate dust. This may be irritating to the respiratory system if inhaled as a generated dust. This product may cause nose and throat irritation, coughing and shortness of breath.
<b>long term exposure</b>	Repeated exposure by inhalation of dry dust may cause serious chronic effects. Silica products contain crystalline silica, and when using the dry product, a portion of this may become airborne as respirable dust. Repeated exposure to respirable crystalline silica dust may lead to silicosis, a serious lung disease. The onset of silicosis is usually slow and lung damage may occur even when no symptoms or sign of ill health have occurred. Silicosis can develop to a more serious degree even after exposures have ceased, and may lead to other diseases including heart disease and scleroderma. Development of silicosis may increase the risk of later development of lung cancer.
<b>Carcinogen Status</b>	
<b>SWA</b>	No significant ingredient is classified as carcinogenic by SWA.
<b>NZEPA</b>	EXPERT JUDGEMENT: CAS 14808-60-7 only triggers Carcinogenic 1A classification if it is in the form of a fine respirable dust in an occupational (chronic exposure) setting. Materials that contain CAS 14808-60-7 in this product are not classified as Carcinogenic by approved suppliers.
<b>IARC</b>	Crystalline silica is classified as carcinogenic to humans (IARC Group 1). However, there is a body of evidence supporting the fact that increased cancer risk would be limited to people already suffering from silicosis.
<b>Respiratory sensitisation</b>	Not expected to be a respiratory sensitizer.
<b>Skin Sensitisation</b>	Not expected to be a skin sensitizer.
<b>Germ cell mutagenicity</b>	Not considered to be a mutagenic hazard.
